Safety Protocols

NEDCC staff will wear face masks and we respectfully ask you to do the same. Social distancing should be observed by maintaining a 6-foot distance and a clean cart will be used to transport collections.

Payments can be accepted by check or credit card. NEDCC staff will record your card information on paper for processing by our staff accountant. All card information will be safely destroyed thereafter and emailed receipts are available upon request.
